* the Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body, Foundation Governors are elected by the Lincoln Board of Diocese in consultation with the Parochial Church Council, Ex-officio Governors are appointed by the Lincoln Diocese Board of Education and Staff Governors are elected by the staff body of the school.

** All Governors' terms of office are 3 years.
